## <u>FEES</u>

Application fees required by the statutes administered by the Commissioner of Financial Protection and Innovation or rules promulgated under these statutes are due and payable upon filing of the application regardless of the action taken thereon and should be submitted together with the application or other filing to which they refer. Checks should be made payable to the "Department of Financial Protection and Innovation" and need not be certified. (See Section 250.15, Chapter 3, Title 10, California Code of Regulations.)

Besides the fees indexed below, costs of examinations (which vary each year) are available from the Department of Financial Protection and Innovation's Office of Management and Budget. Also, publication and copy fees are set forth in Title 10, California Code of Regulations, Sections 260.608 and 260.617.

NOTE #3: Administrative Penalties: Up to \$1,000 for first violation and up to \$2,500 for each subsequent violation, for persons other than broker-dealers and investment advisers; and up to \$5,000 for first violation, up to \$10,000 for second violation, and up to \$15,000 for each subsequent violation, for broker-dealers and investment advisers.
